FNFC Working Groups Community Dialogue Sessions

Both the Co-Management Working Group and Food, Social & Ceremonial (FSC) Working Group will be hosting a series of community dialogue sessions in February and March 2011. The community dialogue sessions will be an opportunity for participants to provide direction to the Working Groups and the First Nations Fisheries Council on key questions and critical issues of importance for First Nations with respect to both Co-management and FSC fisheries.

The Co-management Working Group will kick-off the community dialogue sessions with a two-day Tier 1 and Tier 2 information session to facilitate broad discussions among First Nations and between First Nations and DFO on topics related to Co-Management. The FSC Working Group will 'kick-off' the community dialogue sessions with a one-day Tier 1 session in Nanaimo at the end of February. Following that, both the Co-management and FSC Working Groups will each have one-day Tier 1 (First Nations only) community dialogue sessions in Prince George and Terrace, where participants can have more focused discussion on the challenges, issues and priorities that First Nations face in their relationship with DFO on co-management and FSC fisheries.
